

8th Annual Business Continuity Compensation Report

BC Management, Inc. is pleased to release the Third Annual Business Continuity Compensation Report exclusively for independent contractors. Over 100 independent contractors participated with a majority of the respondents being based in the United States and Canada. The compensation information throughout this report highlights independent contractors only. Total compensation, as referenced in this report, includes base, bonuses and any commissions earned in 2007 and 2008.

Figure 1 highlights the compensations for independent contractors by geographic region, thus detailing compensations by individual country currencies. Only those geographic locations with suitable responses were included in the first table. The study received the greatest response from independent contractors based in the United States; therefore, the remaining tables and charts will focus on the United States unless otherwise noted.

Overall, a majority of independent contractors noticed a decline in their earnings between 2007 and 2008. Our study indicated that 54.8% of all international independent contractor respondents experienced a decrease in their compensation. This can certainly be attributed to the recession that has resulted in many cancelled projects. Average hourly rates have continued to decline for the most part, while on average total compensations within the USA have climbed slightly.

Figure 2 highlights compensation by individual certifications. According to our study the CBCP certification was the leading international certification for independent contractors (34%), and ABCP certified professionals are out earning their certified counterparts. When reviewing the data it was discovered that the majority of these respondents were working 3-4 months longer in 2008.

Figure 3 highlights compensation by the number of certifications. Interestingly enough, the data indicated that those professionals with no certifications enjoyed higher compensations compared to their certified counterparts. Upon reviewing the data we found that the majority of non-certified professionals were degreed (81%) with 19.6% achieving a Doctorate/ PhD.

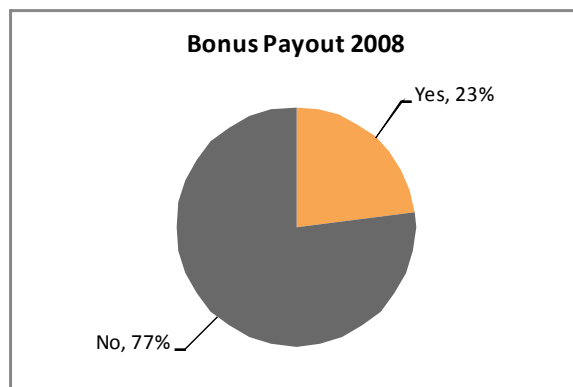

Study Methodology & Statistics

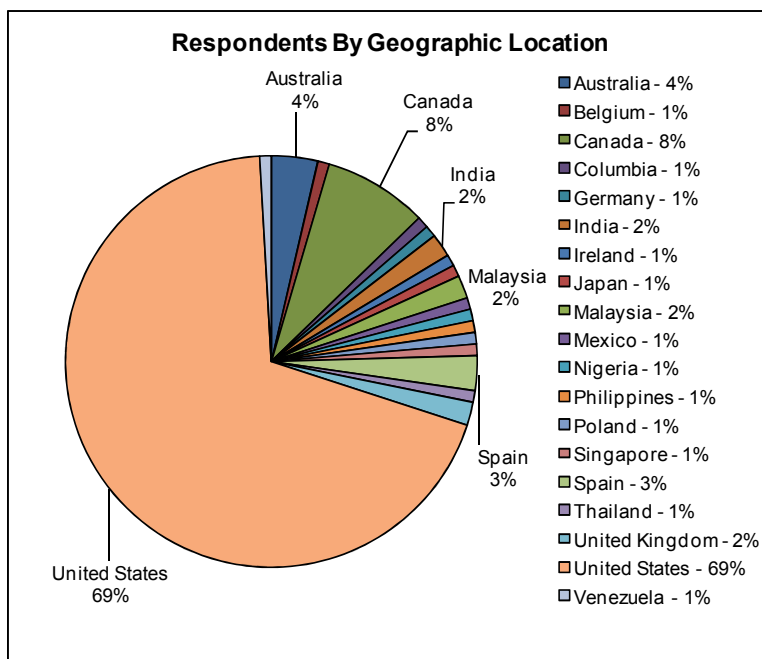
BC Management's 8th Annual Business Continuity Compensation study received over 2,500 participants in over 50 countries. Over 100 independent contractors responded to the study, which collected data on 2007 and 2008 compensations. The study focused on the different factors that impact compensations. Duplicate responses, missing salary data and unintelligible data were eliminated.

The data used in these results was collected between February and April of 2009 via an on-line survey by WorldAPP Key Survey, an independent survey company. The survey was dispersed internationally among multiple associations and organizations involved in the business continuity community and related professions. Respondents were given the option of keeping their identity confidential.

Respondent Characteristics

This report concentrates on Independent Contractors. The study received a total of 114 Independent Contractor respondents. A majority of those respondents were from the United States (76). A significant response was also received from Canada (9) and Australia (4). Responses were also received from several other countries as highlighted below.
